This report is run on a monthly basis.

Period	The Tax Account Period associated with the transaction (in YYMM–YYMM format).				
Posting Date	The date the transaction was posted into the system to the account.				
Deposit Amount	The dollar amount of the monies deposited to your locality.				
Adjustment Amount	The dollar amount of the adjustment.				
Total Amount	Deposit Amount + Adjustment Amount = Total Amount.				
Totals	Total of the Motor Fuel deposit, adjustment, and total transactions reported for the month.
